Pursuant to Article 93 (4) of the Constitution of Republic of Kosovo, Article 16.1 of the Law on Establishment of the Kosovo Security Council, Article 33 of the Law No. 03L-189 “on State Administration” and pursuant to Article 19 (6.2) of Government Regulation No.09/2011 on the Functioning of the Government of the Republic of Kosovo and Article 23, paragraph 10 of the Regulation No.09/2012 on Standards of Internal Organization and Systematization of Jobs in the State Administration,

Approves:

REGULATION (GRK) No. 12/2015 FOR AMENDMENT OF REGULATION No. 42/2013 ON THE INTERNAL ORGANIZATION AND SYSTEMATIZATION OF WORKPLACES IN THE KOSOVO SECURITY COUNCIL SECRETARIAT AND SITUATION CENTRE

Article 1

Purpose

The purpose of the Regulation is to amend and supplement the Regulation no. 42/2013 on the internal organization and systematization of workplaces in the Kosovo Security Council Secretariat and Situation Centre.

Article 2

Article 6, subparagraph 1.4. “Internal Auditor”, is deleted and replaced with “Archive/Protocol Officer”.

Article 3

Article 8 (Internal Auditor) completely deleted.

Article 4

Article 12 paragraph 1, subparagraph 1.19 added after subparagraph 1.18 as follows:

1.19. To register and administer institution assets while also providing technical and operational support for the implementation of best management practices on logistics, systems and procedures.

Article 5

Paragraph 2 of Article 12 is reformulated as follows:

Article 6

2. DA - is led by the Director of Administration who reports to the KSC Secretary. The number of employees at the DoA is eight (8).

Article 7

Article 12, paragraph 2, subparagraph 2.7 “Senior IT/Archives Officer”, is replaced with “Head of Unit for Information Technology”.

Article 8

Article 12, paragraph 2, after subparagraph 2.7 subparagraph 2.8 is added “Logistic/Reception Officer”.

Article 9

Article 13 “Situation Centre” Paragraph 6 is deleted completely and replaced with “Number of employees in the Situation Centre is 9”.

Article 10

Article 14 is completely deleted.

Article 11

Article 15 is completely deleted.

Article 12

Article 16 is completely deleted.

Article 13

Organogram of the Kosovo Security Council Secretariat and Situation Centre is deleted and replaced with the new organizational structure of the Secretariat and the Situation Centre of the Kosovo Security Council.

Article 14

This Regulation enters into force seven (7) days after signature by the prime Minister and it is published in the Official Gazette of the Republic of Kosovo.
